Minutes:

Approve minutes of June Board Meeting (already approved) and summer meeting. Moved to approve by Leona. Seconded by Chris. Approved unanimously.

Notes:

Chris had a question about food for the Pillowcase Palooza.

Decision: An hour before the end of the meeting, we can get a show of hands of how many will be eating. That will give us the chance to know how much pizza to order.

Leona had a question regarding payment for Kirsten's workshop. Where is the money coming from? Will it come from the member support fund or Eileen Anderson? Decision: the funds will come from the Eileen Anderson fund

Chris had a question about whether we should have themes for the show & tells. Decision: Some months we could and some months keep it open. For the September meeting, we could encourage people to show their summer work.

Richie: Has a suggestion of a teacher that he met at the quilt show he was just at: David Sirota. He'll bring the business card to the meeting on Saturday.

Treasurer's Report – Leona

Notes: We're in good shape financially.

Question came up as to whether we need to build up more of a nest egg before our next show in two years. Leona said it depends on the cost of the venue selected. To get more money into the show account, we'd need to raise dues. Right now there's over \$20,000 in that account.
