#### **Reading and Approval of December Minutes**

# **Programming:**

The first session of the Appliqué workshop occurred yesterday, with 17 members registered and participating. Michael reached out to Carolyn Mazloomi, who is interested in presenting at our February meeting in honor of Black History month. Her involvement has not yet been confirmed. Margaret pointed out that our ABC frenzy will be happening right after the February meeting. The board discussed other dates that could be considered for a presentation by Carolyn Mazloomi. Kirsten Fisher is going to give a workshop on how to treat fabric in order to be able to print on it. Barbara Danzi is partnering with Madi Appell to put together a Maria Shell workshop in April. The board agreed that we should use Eventbrite for registration for this program. There will be a thirty-person limit for this workshop, which will take place on April 11<sup>th</sup> and 18<sup>th</sup>.

Our next Quilt Fence show will take place on April 24<sup>th</sup> with a rain date of May 1<sup>st</sup>. The board discussed organizing a "Quilt Along" for the Guild. A free-motion workshop is being planned for May or June.
