Barbara Danzi has agreed to do a trunk show either in April or May, depending on when the ABC Frenzy takes place We will consult with Jennifer Arzberger, our ABC chairperson, to confirm a date.

The Clara Nartey one hour trunk show is all set. We have quilt stands ready for her to use as requested.

The program for our June meeting will highlight the work of our newest members. We are happy to report that we have 19 new members this year. We will ask for participants via our Bee, our Bee Blasts and our in person meetings. We hope to have a rousing slide show.

Margaret is planning a summer picnic as last year's was a big success.
